- 8. While I feel substantial progress has been made due to reforms enacted in 2014 and prior, I would welcome a more independent process similar to that in Albany. A more independent process would increase transparency and ensure bills are not shelved for merely political reasons.
- 29. I support a constitutional convention to amend the New York State Constitution. In addition to discussing the matter with my colleagues at the City and State level in order to move the process forward, I would work with community based organizations, stakeholders and other interested parties in order to educate my constituents on what the process entails and what if any changes in the Constitution they would like to see.
- 30. I applaud the Citizens Union's leadership on these matters. I would continue to work with them and other parties in order to ensure that the role of pay-to-play culture becomes a non-factor in local politics. I think ensuring the Conflicts of Interest Board has the resources necessary to enforce existing laws and regulations are also vital to this effort.

When previously in office, I worked hard at the Council to support important reforms that made the City Council and public officials more accountable and transparent. I also worked on a number of measures to strengthen our democratic process and protect our citizens. Among these include sponsoring legislation to: calling on the New York State Legislature to pass and the New York State Governor to sign into law legislation that would require that paper ballots be designed in a more user-friendly manner; investigating, reviewing, studying, and auditing of and making of recommendations relating to the operations, policies, programs and practices of the New York City Police Department by the commissioner of the department of investigation; including additional information about candidates for federal, state, and county offices in the New York City voters guide; providing email notifications to prospective New York City voters; amending the administrative code of the city of New York to identify, eliminate and prevent discrimination, and promoting human rights in governmental operations; authorizing the Civilian Complaint Review Board to prosecute cases of police misconduct the board has substantiated; and much more. I will continue to work with advocates, officials, colleagues and constituents in order to continue the progress we've made together on these many fronts so important to New Yorkers.
